DEBILIDADES PROCESO DE EVALUACIÓN - PF

- The **one stage evaluation** process, assessed by **two evaluators without interviews** held and **without consensus** meetings presented, lowers its overall transparency.
- The formulation of the **redress procedure lacks** sufficient clarity.
- **No redress procedure** seems to be in place.
- The proposal does not convincingly demonstrate the substantial **involvement of international experts** in the interview panels as required by the MSCA COFUND rules.
- **Transparency of international peer review** in the selection of candidates is **not well demonstrated**.
- An open call is foreseen in order to attract international experts. However, there is **lack of clarity** regarding **mechanisms to ensure the international composition of peer reviewers** dedicated to the evaluation.
- The external and international aspects of the selection process are not convincingly presented. Proposal lacks clarity to what extent external (non-beneficiary) **experts will participate in the peer-review and the interview**.
- There is a **lack of significant involvement of international experts in the interview panels** which does not meet adequately with the international peer review requirement of the COFUND programme.

DEBILIDADES PROCESO DE EVALUACIÓN - PF

- Some aspects of the selection process lack sufficient transparency. In particular, it is **not well demonstrated** that the **evaluation will be entirely bias-free**, and is unclear whether the HR personnel handling the appeals will possess adequate knowledge about the organisation of scientific peer review.
- The proposal does not provide enough justifications for the **considerable time spent on the eligibility check, online interviews and appeal phases** as well as on the proposed complexity of the selection workflow (at the submission level).
- **How the interviews will be standardized** is not sufficiently described, particularly what mechanism will be used to ensure fairness and equality and how interviews will be weighted.
- The **role of international experts** in the interview panel is **limited to that of observers** at the interview phase, which conflicts with impartial and transparent procedures.
- A **video-conference interview** with the applicant is foreseen for the highest ranked applicants, however criteria for **judging merit** in this interview are not clearly stated.
- The **recruitment process is outsourced to a third-party organisation** which can help to make the selection workflow neutral and transparent. However, there is **not enough information** provided about the actual workflow or role of different actors within that organisation to give a clear picture of the recruitment process.

DEBILIDADES EN EL IMPACTO - PF

- It is not explained which **part of dissemination** is dedicated **to create impact on regional, national or international level**.
- Evidence of **action plans to invest in and strengthen human resources on the regional, national and international level** remains unclear.
- It is **not concretely explained how a benefit for regional, national and international level** would follow or would contribute to regional and/or European socio-economic development.
- **Potential and future career prospects** are presented with **limited concrete examples of employability** in academic and non-academic fields. There is insufficient mention of the programme-specific research areas and the connected professional/vocational fields.
- The impact on **enhancing the fellows' careers in the non-academic sector is too limited**, as it is mainly provided by options for secondments

D E B I L I D A D E S E N E L I M P A C T O - P F

- The **Key Performance Indicators** for impact measures after the programme are **not fully developed**.
- The description of **Open Access** is **insufficiently addressed**. There is insufficient specification of open data and FAIR data repository provision. The **Data Management plan** is **insufficiently proposed** at the project level.
- Limited information is provided in relation to the **procedure/key performance indicators to monitor the impact** and effectiveness of the **proposed communication measures**.
- The **planned communication** is **only marginally described** and does not go much beyond some of the dissemination activities (such as social media) and only vaguely identifies target audiences.
- The IPR issues, especially the **regulations with the partner organisations, and the exploitation strategy** are **not addressed** in sufficient detail.
- The **exploitation mechanisms** are **not sufficiently described** in the proposal.
