

INFORMATION ON CLINICAL STUDIES

(For calls that involve clinical studies, project participants must add this document to the application and upload it as separate annex to the proposal part B in the Submission System.)

Clinical studies have a number of methodological, operational and regulatory specificities. Information on these issues is crucial for evaluators to assess the scientific quality and operational feasibility of the proposal. The following set of section headings guide applicants to provide essential information on clinical studies in a standardised format.

Applicability:

For HE collaborative research and innovation:

Single-stage and stage-2 proposals: The use of this template is **mandatory** for single-stage or stage-2 proposals, if the application includes a clinical study. AND it concerns a topic including clinical studies.

For these topics, you will have the possibility to upload the completed template as a separate part of your application in the submission system.

Stage-1 proposals: In the limited frame of a stage-1 proposal, not all methodological details of clinical studies can be fully elaborated. Depending on the characteristics of the study, however, key aspects of clinical study have to be convincingly addressed already at stage 1. This template **cannot** be uploaded as a separate document at stage 1, but relevant aspects of this information should be integrated in part B of the stage 1 proposal template.

For HE IHI Joint Undertaking and Global Health EDCTP3 Joint Undertaking:

Single-stage and stage-2 proposals: The use of this template is **mandatory** for all clinical studies. You can upload the completed template as a separate part of your application in the submission system.

Stage-1 proposals: see under Horizon Europe collaborative research and innovation

For each clinical study performed within the scope of the proposal, essential information according to the below structure should be provided and compiled into one single document per proposal. Each section must be addressed **briefly and concisely**. In case one or more sections do not apply to a particular study, please provide a short explanation.

When the requested information is currently not available (e.g. a clinical study is planned for a later stage of the project and it will be based on or influenced by future results of other studies), the source and the collection of the relevant input should be described.

Information provided in this template does not need to be repeated elsewhere in the proposal but can be referred to.

There are no page limitations for this template, but explanations should be as **concise as possible**.

Excellence (Threshold: 4/5)
Technological breakthrough: Does the technology have a high degree of novelty and higher performance compared to other technologies available or in development? Does the technology indicate high commercial potential?
Objectives: How credible and feasible are the objectives for the planned technology development and maturation? How credible and feasible are the objectives and KPIs for the planned business development process?
Methodology: Is the timing right for this technology/innovation (i.e., feasibility, technological readiness level, unique selling points)? ⁴⁷
Impact (Threshold: 4/5)
Credibility of the impacts: To what extent the expected commercial impact(s) described in the proposal are credible and substantial within the project and beyond (e.g., one or several sectors, setting new standards, etc.)?
Economic and/or societal benefits: To what extent does the proposed innovation have scale up potential including high capacity to gain or create new European or global markets? To what extent is the proposed innovation expected to generate positive impacts for the European Union, Member States or Associated Countries (e.g., strategic autonomy, employment etc.)?
Investment readiness and go to market strategy: To what extent the proposal and its activities contribute to make the technology and the team investment ready (including through IP protection and market validation)? Is there a well-defined and convincing go-to-market strategy and pathway, including what regulatory approvals may be needed (if relevant), time to market, possible business and revenue model?
Quality and efficiency of the implementation (Threshold 3/5)
Quality and motivation of the team: To what extent does the (project) team have the necessary high-quality capabilities and high motivation to move decisively towards market. To what extent do the applicant(s) have the necessary expertise to create a unique commercial value from the emerging technology and develop an attractive business and investment proposition?
KPIs and Milestones: Are both milestones and KPIs present, relevant and clearly defined (measurable, timed, comparable etc.) to track progress along the pathway towards objectives? Have the main risks (e.g., technological, market, financial etc.) been identified, together with measures to mitigate in order to achieve the project objectives?
Workplan and allocation of resources: How appropriate and effective is the allocation of resources (person-months and equipment) between work packages and between project partners? Is the number of project partners well justified?



- Applicants awarded the 'Seal of Excellence' will have access to **EIC Business Accelerator Services** and support to access other sources of funding.

- **Only** awarded to those applicants who give consent to **sharing** the data about their application with other eligible funding bodies

Excellence (GO/NO GO)

Technological breakthrough: Does the technology/innovation – through its degree of novelty/disruptiveness and/or added value/value proposition for the users/customers – compared with competing technologies - have the scaleup potential including potential to create important new markets or significant impact in existing ones at European or global level?

Objectives: How ambitious yet credible and feasible are the objectives for the planned technology development and maturation? How credible and feasible are the objectives (and KPIs) for the planned business development process?

Methodology: Is the timing right for this technology/innovation (i.e., feasibility, technological readiness level, unique selling points)?

Impact (GO/NO GO)

Credibility of the impacts: Is the incipient proposed business model sound and promising? To what extent the expected commercial impact(s) described are realistic and substantial within the project and beyond?

Market and economic impacts: have potential markets/ use cases and users of the innovation been identified? Does the proposed innovation have high impact potential for the European Union, Member States or Associated Countries including high capacity to gain or create new European or global markets?



Investment readiness and go to market strategy: Are the plans to ensure the subsequent financing of the technology/ innovation (e.g.,applying for EIC Accelerator, private investment, patenting/licensing, etc.) appropriate?

Quality and efficiency of the implementation (GO/NO GO)

Quality and motivation of the team: Does the team have the capability and motivation to mature the proposed technological innovation and implement market-related activities?

Risk assessment: Have the risk that might prevent the validation of the innovation in relevant application environment and/or market success been appropriately considered?




FROM TECH TO BUSINESS

- A **'Transition to Technology'** for collaborative project to further develop strategic and high impact technology up to TRL 5/6. This may require a multi beneficiary approach (e.g. SMEs, RTOs and potential users / customers).
- A **'Transition to Market'** for project led by an SME/Start-up that identifies an opportunity in the research results towards a specific market application. It may require, or lead to, a license agreement with the SME.
- A **'Transition to Entrepreneurship'** for project driven by entrepreneurial researchers to turn research results into a viable product by looking for a suitable business model or creating spin off company.



Las actividades a realizar deben incluir un "suitable mix" entre:

- ✓ **Desarrollo tecnológico y actividades de validación** (en entornos relevantes, con ejemplos de aplicabilidad concretos) en base a los resultados obtenidos en un proyecto anterior (el "proyecto de entrada" en TRL3-4) para alcanzar un TRL5-6.
- ✓ **Desarrollo comercial y de negocio:** (BRL1-3)
 - ❖ Prospección de mercado, propuesta de valorización, caso y modelo de negocio, perspectivas de crecimiento, protección de la propiedad intelectual, análisis de la competencia, etc.
 - ❖ Metodologías centradas en el usuario/cliente para incrementar las posibilidades de éxito comercial futuro de la innovación a introducir en el mercado (favoreciendo el feedback temprano)
 - ❖ Regulación, certificación y estandarización (cuando sea relevante)



Al final del proyecto deberíamos estar listos para la siguiente etapa, que puede ser solicitar el EIC Accelerator (si es una pyme, incluidas las startups o spin-offs), buscar otros inversores o fuentes de financiación, entrar en acuerdos de licencia o colaboración con terceros, u otras vías para el despliegue en el mercado.
