

- Destination and use of the equipment in your institution
- What is the benefit from the donation for your institution
- What resources your institution will make available for the commissioning and operation of the equipment institution will make available for the commissioning and operation of the equipment
- What kind of nuclear licence your institution posesses
- What access scheme you would envisage to allow the JRC Karlsruhe to use the donated equipment for own work and its Open Access programme
- What process can be implemented to verify if the donated equipment is used for the correct purpose.
- Existing Collaboration agreements with JRC or similar cooperation tools

Declaration on 3 Honour 2 on the use of the lab

 exclusively for scientific and educational purpose, duly signed by the legal representative (paper or electronically) with a description of the planned use (include information on an existing nuclear licence).
Be ready to present supporting evidence pieces (as stated in the Administrative Specifications, Chapter 2.2.3) at any time throughout the process.

Final Remark

Keep in mind that the award committee will establish a list of candidates, based on the following award criteria

- Declaration about the intended use of the equipment. It shall be related to research in the field of Basic Actinide Science and/or Chemistry of the Actinides and/or Radioactive Waste and Decommissioning (including a short description of the candidates own work, competence and (educational) efforts in the relevant fields).
- Present collaboration agreements between the JRC and the candidate.
- Existing license or other adequate document allowing the use of natural uranium and thorium material as a minimum.
- Destination and use of the equipment (full use of the capacity of the SSLS)

Final Remark

- Benefits for the applicant
- Resources that will be made available for the commissioning (in year one and two after the contract signature) and operation (after year two of the contract signature) of the SSLS
- Plans to allow for JRC use (including Open Access) of the equipment for 5 years minimum after bringing the equipment into operation
- Measures to be taken to give visibility to JRC Karlsruhe and its Open access scheme
- Plans for verification if the donated equipment is used for the correct purpose during the minimum period of 7 years
